Faculty Position in Management (Tenure Track)

Indiana University's Kelley School of Business Indianapolis invites applications for a tenured/tenure-track position in Management beginning Fall 2023.

Appointment rank will be dependent on qualifications and research history. Qualified candidates for tenure-track positions must hold a Ph.D. from an accredited institution, have excellent research and teaching skills, and must demonstrate the ability to produce scholarly work at the highest level. Management faculty teach in MBA and/or undergraduate programs. Faculty in all areas are encouraged to apply, with a preference in organizational behavior.

Minimum requirements include a Ph.D. (or ABD status, in the case of the assistant rank) in Business or a related field from an AACSB accredited institution, evidence of a high level of scholarship or the potential to establish a strong scholarly record, and evidence of teaching excellence. Extensive publication in top-tier, refereed journals as well as evidence of the ability to mentor junior faculty are requirements for applicants applying for a senior tenure-track appointment.

Indiana University's Kelley School of Business has over 11,000 students, 110,000 living alumni, and 300 full time faculty. The Kelley School of Business provides programs in two locations: Bloomington and Indianapolis. The Kelley School Dean administers programs at both locations and the faculty in Indianapolis are part of a unique interdisciplinary department of the school.

The Kelley School of Business Indianapolis has over 1,800 students (1,200 undergraduate and 600 graduate) and over 60 full-time faculty. The Kelley School has a broad and excellent repertoire of programs, including undergraduate, MBA, MS Accounting, and MS Taxation. Our MBA programs include in-residence (part-time in Indianapolis and full-time in Bloomington), online (Kelley Direct), and executive MBA programs. In 2013, the Kelley School welcomed an inaugural class into its Business of Medicine MBA program for practicing physicians. The Kelley School has consistently been ranked among the top MBA programs in the world. The Evening MBA program in Indianapolis is currently ranked 11<sup>th</sup> among part-time MBA programs in the United States. The Kelley School Indianapolis provides an excellent research environment, with attractive teaching loads, generous research support, and a stimulating intellectual environment. The multi-disciplinary faculty is both very collegial and very productive.

The Indianapolis program is located on the campus of Indiana University Purdue University Indianapolis (IUPUI). IUPUI is Indiana's premier urban research university and a core campus of Indiana University. It is a highly regarded and successful 53-year-old joint venture between Indiana University and Purdue University. It enrolls over 30,000 students, representing all 50 states and 142 foreign countries and has more than 3,800 faculty. IUPUI consists of eighteen degree granting schools, including the Kelley School of Business, Indiana University's Schools of Public and Environmental Affairs, McKinney School of Law, Liberal Arts, Lilly Family School of Philanthropy, Informatics, Medicine, Dentistry, Fairbanks School of Public Health, and Nursing and Purdue's Schools of Engineering and Technology, and Science.

As an institution located in a vibrant city atmosphere, the school provides excellent opportunities for a career and high quality of life. Indianapolis is the fifteenth largest city in the United States and the 34<sup>th</sup> largest metropolitan area in the United States, with a population of two million. It is the home of the Indiana state government, is considered to be one of America's most livable urban centers, and is a burgeoning center for R&D. The campus' location is within blocks of what Forbes and Livability.com rank as one of the best downtowns in the United States and a major healthcare campus, which facilitates the advancement of research and teaching while presenting unique opportunities for internships, partnerships, and community engagement. Indianapolis boasts five professional sports teams; world-class museums including the world's largest children's museum; numerous companies and company headquarters including Eli Lilly and Company, Finish Line, Roche Diagnostics, and Rolls-Royce to name a few; and a rich cultural heritage.

As the state's premier urban research institution, IUPUI is committed to being a welcoming campus community that reflects and enacts the values of diversity, equity and inclusion that inform academic excellence. This statement should be submitted under "Diversity Statement" in the Required Documents.
